Cost: Fee is \$100 for the GED exam. Re-test fees are \$20.00/test and should be paid to the Cashier in the Administration Bldg. GED candidates should bring their receipt and I.D. to the Academic Support Center (located in the back of the LRC). **Note:** Examinees may take the GED a maximum of 3 times in a calendar year. Cancellations within 72 hours of the test are eligible for a refund. If examinees do not cancel and reschedule, a refund will not be granted. All GED candidates have one opportunity to reschedule. **Please indicate the session you prefer:**
