1. DRAMA 24 will indeed be removed from the approved DCG list after Summer 2019. Beginning Fall 2019, students will only receive CSU GE credit.
2. YUR 1A has been added to the approved DCG Domestic course list effective as of Spring 2018 (first date listed in ASSIST).

Hi all,

Happy Friday! Here are some updates:

I'm still waiting to hear about when the ADT/TMC public site will be fully updated.

I've attached a more complete DCG list that includes additional courses that have been approved since ASSIST was last updated in December 2016. Please feel free to share this with your senate and counselors if they would find it useful in the absence of ASSIST, but this document is not intended to be distributed to students directly. A few notes about this document:

1. We'll follow up with Marla about DRAMA 24 which is noted as "under review / tentatively ending Summer 2019".
2. I have completed a preliminary review of the CR local area E multicultural understanding requirement courses that were not previously identified as "DCG". After consulting with our evaluators and some faculty, I've added the following:
  - MUS 12 effective Fall '17 based on the revised course description
  - ANTH 3H (new honors course, ANTH 3 already approved)
  - SOC 10H (new honors course, SOC 10 already approved)
3. I need to do some additional research on the other area E multicultural understanding courses and will reach out to Marla next week on this.

I definitely see opportunities here, but I also see why, historically, some of these were not approved. In at least a few cases, it has more to do with decisions that were made about HSU curriculum and what really "belongs" in DCG, rather than this being any kind of reflection about CR courses or curriculum so...my thoughts are that we need to thoughtfully "unpack" this from a holistic perspective rather than drawing arbitrary boundaries about what can and cannot be approved. Speaking generally though, the key is that DCG courses need to be *centrally organized* around the themes of diversity and common ground - and this focus should be clear in the course description and outline.

We'll keep working on this and taking a closer look at the course outlines, seek input from faculty and hopefully add a few more of these to the list in the coming weeks...stay tuned.

**Subject:** Follow up from articulation meeting btwn HSU & CR

Good afternoon,

Happy new Year! It was so nice to finally meet face to face with you all back in December. I intended to send a follow up right after our meeting but got carried away with end-of-semester activities, so here I am circling back on some of the action items from the meeting so we can keep the lines of communication open.

1. The Kinesiology ADT will be reaffirmed as 'similar' to some of our Kinesiology concentrations very soon. I am working with Academic Programs to clarify which concentrations (Teaching, Pre-PT, or Exercise Science) will be similar. I expect we will have this tied up before the end of the month.
2. In response to one of the comments about possibly creating major pathways in CR's catalog with HSU articulation/major prep info, or transfer advising sheets for individual majors, I wanted to provide a document from CIAC (the professional organization for California Articulation Officers). The attached document is from the mid-2000's, but still stands as an active best practice recommendation from CIAC with regard to "transfer advising sheets". I understand we have all had extra challenges in the absence of current ASSIST data, but there are a number of reasons we discourage these types of sheets and no longer provide or maintain them ourselves. Of course it is up to your campus what is needed for your students, but I would caution against this approach for all of the reasons outlined on this document.
3. Tyler is preparing and formatting a spreadsheet of CR-to-HSU articulation agreements from 16/17, 17/18 and 18/19 to meet your needs in the absence of ASSIST data. That will be sent over when it is ready.
4. Approved Diversity & Common Ground courses are published on ASSIST. You can find the 16-17 listing on "old" assist, using the "GE/Breadth" link below and selecting the Diversity & Common Ground requirement. **I will follow up next week with a complete listing, including any recent approvals.**
