Dear PRC members,

Just a point of clarification. In a technical sense, Stephanie is correct that we will **indirectly** be evaluating resource requests. That said, we **won't** be doing what the former BPC did in terms of "ranking" the individual resource items. What the PRC **will** be doing is reviewing programmatic plans that contain resources as part of the plans. We will apply some (hopefully simple) rubric to the evaluation of programmatic plans that contain resources and the PRC's ranking of plans will be sent to a district-wide, representative committee for further review, discussion, consultation and, ultimately, action. Deans and directors will also use the PRC's plan ranking as guides to inform their discretionary spending.

This new process will be discussed in more detail at our first meeting this Friday. Angelina Hill and Paul Chown will attend the meeting to provide additional clarification of the process and the PRC's role in it.
