 Recruitment at the high school level will continue by the 1 full-time faculty within the District as well as out of the District. Additionally, the District has to support recruitment efforts through advertisement, accessibility, and update the website to be user-friendly/attractive.
- 2. The Dental Assisting Program reduced the DA 166, Dental Assisting Functions in Dental Practice management course from 1 unit to 0.5 units. Additionally, two new courses were created, but used existing units from another course that was reduced in units. If the Communications and Nutrition requirements were eliminated the Program would not meet CODA Standards. If the Dental Assisting Program eliminated any further courses the Program would not meet the hour requirements by the CODA Standards and DBC requirements.
