Pru Ratliff called the meeting to order at 1:03 PM.

Allocations for 2021-22 & 2022-23 / Report out on Webinar - Governor's Budget

• Brad Albee noted that there are 2 teachers providing GED and ESL, there are currently 2 in the group, and some doing drop in. Doing a citizenship class online in the evenings. Brad also mentioned that they have a better flex

of schedules now. Finally, Adult Education is working on CNA classes again, after most of the facilities took on

this training for a while.

Randy Fugate noted that they are providing HiSET testing, and that language classes are still on hold because of

COVID. Randy also mentioned that they are looking @ the CAN program as well as welding classes.

• Pru Ratliff noted that there currently are no face to face Adult Education classes, and there are 5 classes

(correspondence) at the Humboldt County Correctional Facility. The department is currently doing a review of

their online Adult Education classes. The sign language class that is currently being offered this spring is a

success! Pru also noted that the Medical Assisting program will be moving to Adult Education (from Workforce &

Community Education). Pru also mentioned that CR has an upcoming 40 hour Wildland Fire School in March that

will be held in Del Norte.
