

FINANCIAL AID ELIGIBLE ACADEMIC PROGRAMS

Federal regulations require students receiving federal student aid to be enrolled in and make progress toward an eligible program. **All Associate Degrees (AA/AS/AS-T) are financial aid eligible programs**, but **only those certificate programs indicated below are currently eligible for financial aid**. If enrolled in a NON-eligible program, as indicated below, you are not eligible for most types of financial aid (grants, loans, work study). However, if otherwise qualified, you *may* be eligible for the Board of Governor's fee waiver.

You must have an eligible educational goal in addition to being enrolled in an eligible academic program. **Eligible educational goals for financial aid purposes are: Transfer with AA/AS (Ed goal A); Transfer without AA/AS (Ed goal B); AA/AS without transfer (Ed goal C); Vocational Certificate without transfer (Ed goal E).**

If you plan to earn both an associate (AA/AS) degree and a certificate, declare the AA/AS degree as the current program. Even though an AA/AS degree may be eligible, the certificate in that same area may not be (i.e. ECE).

Federal regulations limit the amount of units students may attempt; so take courses applicable to your program. This limit applies whether you received financial aid funding for the courses or not!
