The Accrediting Commission for Community and Junior Colleges, at its meeting January 8-9, 2025, reviewed the Institutional Self-Evaluation Report (ISER) and evidentiary materials submitted by College of the Redwoods. The next report from the College will be the Midterm Report<sup>1</sup> due on October 15, 2028. The institution's next comprehensive review will begin with Team ISER Review in the spring term of 2031 and conclude with a Focused Site Visit in the fall term of 2031.
