

**Memorandum of Understanding
Between Redwoods Community College District
And California School Employees Association
And Its College of the Redwoods Chapter 509**

This Memorandum of Understanding is hereby entered into between the Redwoods Community College District ("District") and the California School Employees Association and Its College of the Redwoods Chapter 509 (collectively "CSEA") pursuant to the Education Employment Relations Act and the Collective Bargaining Agreement between the parties to resolve the impacts and effects of a memorandum of agreement between the District and the Hoopa Valley Tribe.

WHEREAS, the District and the Hoopa Valley Tribe have entered into a Memorandum of Agreement for services to be provided by the District on the Hoopa reservation, which is attached hereto and further known as Exhibit A (Memorandum of Agreement between Redwoods Community College District and The Hoopa Valley Tribe);

WHEREAS, CSEA was a party to discussions that culminated in the completion and execution of Exhibit A;

WHEREAS, the parties desire to enter into this MOU in order to resolve the impacts and effects on CSEA bargaining unit members resulting from the agreement between the District and the Hoopa Valley Tribe.

NOW THEREFORE, the parties agree as follows:

1. Services provided by the District at Klamath-Trinity Instructional Site (KTIS) will adhere to all applicable mandates, laws and policies pertaining to California eCommunity eColleges, including the California Education Code and Title 5.
2. The District will provide relevant training to classified staff who will be working at ~~Hoopa~~KTIS, including training on College of the Redwoods policies, procedures and operational changes impacting students and staff.
3. The District will perform routine maintenance and install program upgrades on District owned computers at Klamath-Trinity and other equipment used by classified employees, based on mutual agreement of District and Hoopa Valley Career and Technical Education Program (HCATEP).
4. The District will manage and support ~~Klamath-Trinity~~ KTIS IT technical infrastructure, ~~used by classified employees of the District.~~
5. If the District and the Hoopa Valley Tribe modify or amend the agreement attached as Exhibit A, the District and CSEA will immediately meet to negotiate any possible impacts and effects resulting from the changes.

The foregoing constitutes the full and final agreement of the District and CSEA regarding the impacts and effects arising out of the agreement between the District and Hoopa Valley Tribe, and other than specifically provided herein, ~~CSEA hereby waives the opportunity to further negotiate the matters set forth in this MOU or any resulting impacts and effects, and agrees to forgo any arguable legal remedy regarding the same.~~


