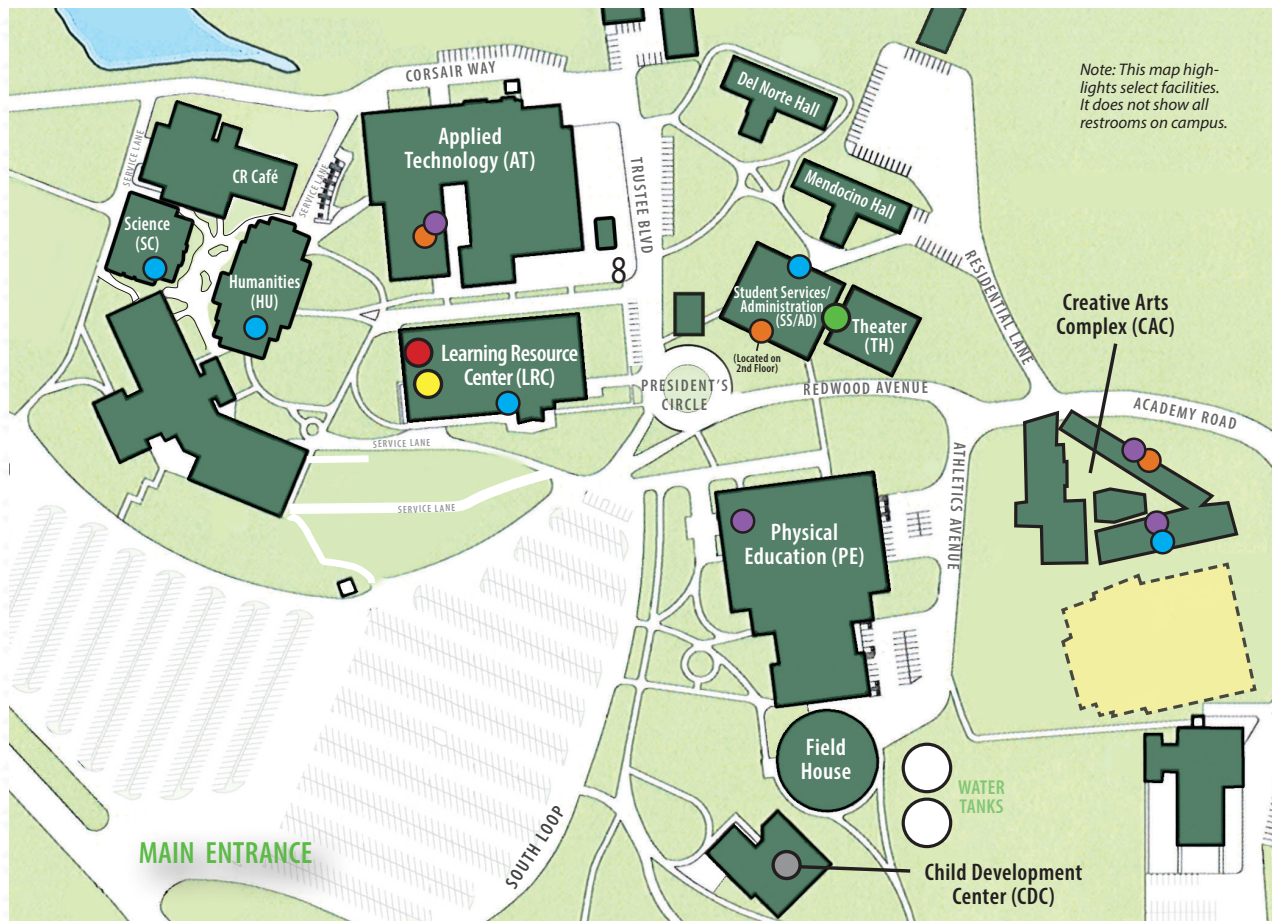

Did you know you may qualify for additional support services through SASS?

Student Accessibility Support Services (SASS) assists students with physical and mental health conditions—including pregnancy-related issues—by identifying accommodations to reduce barriers to education.

Available services include:

- Counseling and advising
- Priority registration and assistance
- Alternate print formats (Braille, large print, audio, E-text)
- Adaptive technology (screen readers, speech-to-text, etc.)
- Testing accommodations
- wASL interpreters
- On-campus transportation (Eureka only)
- Note-taking assistance and digital recording tools
- Captioning
- Referrals and advocacy
- Learning disability assessments
- Adaptive PE (PE 90, 98, 298, 302)
- Living skills courses (GUID 206–211, 252)
- Academic support via LIGHT Center courses (GUID 145–148, 246): tutoring, learning strategies, technology help, time management, and more
