Catalog Description

An examination of the special issues involved in the etiology (causes, origins), treatment and prevention of all types of substance use disorders and process addictions among specific populations of high-risk groups, with special concerns or problems unique to that population.

2. Describe and analyze effective trauma-informed co-occurring treatment approaches.
