An exploration of the scientific approach to the livestock industry encompassing aspects of animal anatomy, physiology, nutrition, genetics, and epidemiology. Emphasis on the origin, characteristics, adaptations, and contributions of livestock to the modern agriculture industry.

# **Course Student Learning Outcomes and Objectives**

The main concepts for this course will ask students to:

- Identify animal contributions to the development of human civilizations.
- Describe economically significant breeds of animals and their unique adaptations.
- Describe the function of the major body systems.
- Identify reproductive cycles and biotechnological principles of animal reproduction.
- Analyze genetic change through artificial/natural selection.
- Discuss nutritional needs for various body functions.
- Describe animal behavior as it relates to animal domestication, health and performance.
- Explain basic strategies for disease control, prevention and management.
- Utilize the scientific method to collect data, calculate production parameters and make scientifically based management decisions.
- Identify and discuss current issues affecting animal agriculture.

# **Course Requirements**

In order to succeed in this class, participation in Canvas is required. ## Make-up policy for quizzes

undermine your learning and curtail the development of your critical and creative thinking skills. In addition, AI outputs are often unreliable and frequently subject to bias. For these reasons, the policy of this class is that AI cannot be used at any point in the completion of class assignments, including discussion posts. Any or all of your assignment submissions and discussion posts may be screened by AI detection software, but the real penalty for AI misuse is that you will miss out on an opportunity to learn.

## **Disruptive Behavior**

Student behavior or speech that disrupts the instructional setting will not be tolerated. - 6. If safe to do so, notify key administrators, departments, and personnel.
- 7. Do not leave campus, unless it is necessary to preserve life and / or has been deemed safe by the person in command.

## **Klamath-Trinity Campus Emergency Procedures**

- 2. Lock all doors and turn off lights if in lockdown due to an active shooter or similar emergency.
- 3. Close all window curtains.
- 4. Get all inside to safe location Kitchen area is best internal location.
- 5. If a police officer or higher official arrives, they will assume command.
- 6. Wait until notice of all is clear before unlocking doors.
- 7. If safe to do so, move to the nearest evacuation point outside building (Pooky's Park), directly behind the Hoopa Tribal Education Building.
- 8. Do not leave site, unless it has been deemed safe by the person in command. Student Support Services (required for online classes)
