This class uses a POST standardized test of 94 questions with a required pass point of 75%. This course is graded Pass/No Pass. If a student fails the initial test, the opportunity for remedial training and a retest using an alternate version of the same test will be allowed. A second fail constitutes a no pass of the course.
