#### **Catalog Description**

A study of current issues facing the criminal justice system. Such issues include police use of force, capital punishment, mandatory sentencing laws, militarization of policing, crime prevention strategies, and juvenile delinquency and gang crime. Analysis of these issues will also consider whether and if so, the extent to which the criminal justice system improperly discriminates against diverse multicultural groups in our society.

- 5. Follow established procedures for the specific emergency as outlined in the College of the Redwoods Emergency Procedure Booklet, (evacuation to a safe zone, shelter in place, lockdown, assist others if possible, cooperate with First Responders, etc.).
- 6. If safe to do so, notify key administrators, departments, and personnel.
- 7. Do not leave campus, unless it is necessary to preserve life and/or has been deemed safe by the person in command.

## **Klamath Trinity Campus Emergency Procedures**

  - f. Notify Public Safety 707-476-4111.
- 2. In the event of an emergency, the responsible district employee on scene will:
  - a. Follow established procedures for the specific emergency as outlined in the College of the Redwoods Emergency Procedure Booklet.
  - b. Lock all doors and turn off lights if in lockdown due to an active shooter or similar emergency.
  - c. Close all window curtains.
  - d. Get all inside to safe location Kitchen area is best internal location.
  - e. If a police officer or higher official arrives, they will assume command.
  - f. Wait until notice of all is clear before unlocking doors.
  - g. If safe to do so, move to the nearest evacuation point outside building (Pooky's Park), directly behind the Hoopa Tribal Education Building.
  - h. Do not leave site, unless it has been deemed safe by the person in command. Student Support Services (required for online classes)

Assignments:

You will complete an issue essay for each chapter/issue discussed in class. You will be given detailed instructions for their completion and electronic submission to the Canvas website for grading via Turnitin.com. I will grade them on the Turnitin site, where you can view grades and my comments. If these assignments are turned in late, I will assess a late grade penalty of my choosing. Employment issues, childcare, and computer issues are <u>not</u> excuses for late submission of any late work.

The issue briefs will require some research outside of class. The proper use of standard English, which includes grammar, spelling, and proper punctuation are all part of the grade for each writing assignment as well as depth and accuracy of your responses.

Attendance:

Attendance is required for this course; it is a discussion-based course and much of the course information will not come from the textbook alone. Classroom discussions and small group work are an important part of your grade.

**Assigned Readings:** 

Every week (some topics may take two weeks), there will be assigned readings and occasionally videos posted on Canvas, although this is not an online course Canvas will be utilized in a comparable manner.

Plagiarism is defined as claiming any work of another person as your own without attribution to the original author. It also includes taking a substantial portion (30% or more) of your assignment from another source, whether or not credit is given to the original author. This would include work from another student even with their permission. If plagiarism is discovered, the instructor may impose a failing grade for the assignment or a failing grade for the entire course.
