### Catalog Description

A study of engineering design graphics for engineers and drafters with an emphasis on technical drawings and an introduction to computer-aided design (CAD). Topics include the development of visualization skills; orthographic projections; dimensioning and tolerancing practices; and the engineering design process. Assignments develop sketching and 2-D and 3-D CAD skills. The use of CAD software is an integral part of the course.

### Course Student Learning Outcomes

1. Develop orthographic projections, isometrics, obliques, and perspective pictorial representations of design using CAD and sketching.
2. Present engineering drawings using current industry standard documentation and annotation techniques.
3. Define terminology related to engineering graphics.
4. Prepare a professional portfolio.

Assignments consist of hand-drafted worksheets and CAD drawings. Students are expected to turn in all Assignments in person via a hard copy. Any Assignments turned in online will not be accepted unless discussed with the instructor prior to the due date. Assignments that are 1-2 and 3-4 class sessions late are penalized 20% and 40%, respectively. Assignments past 4 class sessions late are worth 0 points, however, students should still complete them for the Portfolio. No Assignments will be accepted after the last day of lecture.

Participation is based on attendance, and weekly quizzes or discussions on Canvas. Participation assignments are not accepted late.

The Portfolio is a collection of all Assignments in one 3-ring binder. Both the graded and a corrected version, if necessary, of the Assignment should be presented in the Portfolio for full credit. The Portfolio will not be accepted late.

The Midterm and Final Exams will not be accepted late. The use of in-class notes is allowed during the exams. Any type of communication with other people or AI is not permitted.

## AI Use Class Policy

Recent advancements in generative artificial intelligence (AI) have made large language models such as ChatGPT and Google's Bard widely available. However, overuse of these tools in this class can undermine your learning and curtail the development of your critical and creative thinking skills. In

addition, AI outputs are often unreliable and frequently subject to bias. For these reasons, the policy of this class is that AI cannot be used at any point in the completion of class assignments, including discussion posts. Any or all of your assignment submissions and discussion posts may be screened by AI detection software, but the real penalty for AI misuse is that you will miss out on an opportunity to learn.

Recent advancements in generative artificial intelligence (AI) have made large language models such as ChatGPT and Google's Bard widely available. Sometimes, using these tools appropriately can help us overcome barriers and allow us to focus on deeper learning. However, overuse of these tools can undermine the development of our critical and creative thinking skills. In addition, AI outputs are often unreliable and frequently subject to bias. For these reasons, it is sometimes appropriate and sometimes inappropriate to use generative AI in the completion of assignments or in discussion posts. For this class, please see the specific assignment instructions for guidance on how and when generative AI tools may be used appropriately as we're working on and learning from a particular assignment. Also, please keep in mind that you are responsible for anything you submit; please carefully review all AI-generated outputs, screening them for accuracy, bias, appropriateness, and fidelity to your perspective.

Generative AI tools, such as ChatGPT and Google's Bard, are likely to be widely used in the workplace moving forward. It's important for you to understand how to use them ethically and effectively. For that reason, in this class, you will sometimes be invited to use such a tool in the completion of an assignment. In this class, using generative AI tools is not cheating if the outputs are screened by you for accuracy, bias, appropriateness, and fidelity to your perspective.

## **Disruptive behavior**

Student behavior or speech that disrupts the instructional setting will not be tolerated. Disruptive conduct may include, but is not limited to: unwarranted interruptions; failure to adhere to instructor's directions; vulgar or obscene language; slurs or other forms of intimidation; physically or verbally abusive behavior; and unpleasant fragrances such as cannabis and body odor. 6. If safe to do so, notify key administrators, departments, and personnel.
7. Do not leave campus, unless it is necessary to preserve life and/or has been deemed safe by the person in command.
