Catalog Description

An exploration in the history of the United States from the original inhabitants of the North American continent to the end of the Reconstruction period after the American Civil War. Of special importance is how the social, political, diplomatic, cultural, ethnic, economic, and technological/scientific relations and institutions changed over time. The course will also introduce students to the nature of historical interpretation and how to interpret sources written during the historical time periods investigated in the class.

Course Assignments:

Group Essay Quizzes: Three times throughout the semester there will be a group exam. Groups will be selected randomly, and the exam will be taken in the classroom. There will be a total of four questions on the exam.

Final Exam: The final exam will consist of four essay questions but will be completed individually instead of within a group.

Primary Source Summaries: Five times throughout the semester (six if an individual wants extra credit) students will submit a primary source summary of at least 300 words. The primary source summary must include a summary of the primary source, a brief discussion about the author(s) of the work, and how you think this primary source can aid in the understanding of the historical period. The submission must include the citation for the primary source document. The list of primary sources to choose from will vary depending upon which primary source summary is being submitted.

Research Paper:

Choose one of the following two prompts:

Analyze the political, economic, social, or moral aspects of slavery (only choose one) from a northern and southern perspective. The research paper should examine the perspective of those who are pro-slavery, non-expansionist, and abolitionist. At least six primary sources and two secondary sources are required to be used for the research paper. One of the required sources is *The Autobiography of Frederick Douglass*.

or

The Declaration of Independence was a radical document for 1776. Analyze how the Declaration of Independence inspired the social movements of abolition, racial equality, and/or gender equality. One of the required sources is "What to the Slave is the Fourth of July" by Frederick Douglass.

The research paper should be at least six pages (not counting the title page and the references) and no more than ten pages. The paper must also be typed, double spaced, Times New Roman size 12 font and APA citations.

Citations: All citations and references in this course will use APA citation standards. If you need assistance the <u>Purdue University Online Writing Lab</u> is an excellent resource as a citation guide.
