This class provides the application of resistance in the form of weight machines, free-weights, and body resistance exercises to condition the muscular system of the body. This class is intended for beginning weight trainers who need more individual instruction.

- 1. Construct an individualized strength training program.
- 2. Keep records in a weight-training log and make program changes as indicated.
- 3. Identify the basic concepts and terms of resistance training.
- 4. Demonstrate proper exercise technique.
